## **Minutes of Online Deliberations on Internship organized by the JUT, AICTE and NEAT at 12.00 O' Clock on 4 th July 2022:**

Online Deliberations on Internship was organized by the JUT, AICTE and NEAT at 12.00 O' Clock on 4 th July 2022 to discuss the agenda points such as 100% registration of students and % MOUs with the industries for AICTE approved institutions functioning in the state of Jharkhand. In an opening remark, Shri Buddh Chandrashekhar, CCO, AICTE explained the objectives of benefiting the students by getting themselves registered on internship portal. He explained about operation of internship portal. The students and companies both can register themselves on internship portal from where the companies would select students for internship as per their needs and requirements. The students would get exposure to the industrial environment, learn industrial management and changing practices in the field of technologies, innovation and creativity. They will gain experience and skill on how to implement their knowledge and bubbling ideas. He stated that more internship opportunities would emerge by 2025. Union Government institutions such as Ministry of Rural Development, Ministry of Urban Development and Ministry of Social Empowerment etc. are also associated with the internship drive with objective to fulfill the Government initiative "SABAKA SAATH, SABAKA VIKAS".

Shri Vipin Kumar, Assistant Director, AICTE, New Delhi explained about how the students would go for registration on internship portal. For this purpose, the students could visit the site <http://neat.aicte-india.org/>.

He also explained about 'NEP-2022', AICTE Language Translation Tool, One Nation One Data, Amrit Sarovar Mission.

### **After detailed discussion and deliberation, the following has been decided:**

1. An admin module will be developed for Director, Technical Education Jharkhand for regular update on the progress. College wise complete Details should be available in this module.
2. It was suggested to nominate a co-ordinator at state level for review and Follow up about the instruction and guidelines shared by the AICTE time to time.
3. All the Principal/Director/Vice Chancellor will ensure that 100% students Should register on the portal.
4. All the Principal/Director/Vice Chancellor will ensure that at least 5 MoU Of their industry partners are uploaded and all the industry partners has been registered on the AICTE Internship Portal.
5. A letter from the office of Director Technical Education Jharkhand will be issued to all Institute/university regarding the point number 3 and 4.

6. It was decided that the awareness workshop related to initiatives of AICTE NEAT Cell scheme among the students will be held in various Cities. If required, the officer from AICTE may be called by the D(TE), Jharkhand to narrate about this scheme physically.
  7. Also, DTE Jharkhand will request through a letter to all the industry for Onboarding on AICTE Internship Portal and offer the internship Opportunities for the betterment of the student of the state.
  8. Director, DTE will review the progress by conducting a meeting with a Monthly frequency. A member of AICTE team will join the same. And The report of the same will be submitted to NEAT Cell.

All the stakeholders can provide their inputs for improvement of the portal and AICTE will incorporate if required.

Undersigned presided over the deliberation and expressed hope that students affiliated with JUT would register themselves and draw benefits.
